Alumni Establish Scholarship for Members of the Black Student Union

The Fairmont State Black Student Union Alumni Association has created a scholarship in support of the student organization they serve.

The Fairmont State University Black Student Union Alumni Association Endowed Scholarship will be available to active, working members of Fairmont State University's Black Student Union. Qualifying students who are sophomores, juniors or seniors will demonstrate academic success, along with campus and community engagement in order to be eligible. Black Student Union Legacy members are also eligible for this scholarship.

"The Fairmont State Foundation is beyond grateful that the Black Student Union Alumni Association has come together to establish an endowment that will continue their mission in creating equal access to opportunities for students while enhancing student's success," said Fairmont State Foundation Development Officer, Tori Anselene.

Fairmont State's Black Student Union was established to foster open dialogue among students of color, the Student Government Association and school administration with the goal of creating equal access to opportunities. Additionally, the organization strives for fair educational, cultural and social acceptance at Fairmont State University.

"The creation of this endowment will support students who are working toward a future of diversity, equity and inclusion in education," stated Fairmont State Foundation President, Gary K. Bennett.

From its inception in 1969, the Black Student Union has been active on campus and within the community. Black Student Union has been active on campus and within the community. Black Student Union activities include leading the BSU Gospel Choir, holding events for Homecoming and offering special programs at local churches in celebration of Black History Month each year. The organization currently hosts programming to address and encourage African American and multicultural education.

When asked why the Black Student Union Alumni Association chose to establish this scholarship, Jacqueline Dooley, President and Chair of the organization, explained, "The Black Student Union alumni want to offer a helping hand, reaching back to deserving youth to lift them up and aid in their academic success with this financial support."

A3L Federal Works Establishes Scholarship for Students in STEM

Fairmont, West Virginia's A3L Federal Works, LLC has committed \$25,500 to the Fairmont State Foundation to establish a scholarship honoring the father of President and CEO, Roya Maher.

The Mr. Karim Maher Memorial Scholarship will offer four annual awards of \$1,250 to Fairmont State University students, with preference given to minorities and women majoring in science, technology, engineering or math (STEM) related fields.

"It is through the generosity of organizations such as A3L Federal Works that the important education in the STEM areas will go from good to excellent at Fairmont State," said Gary K. Bennett, Fairmont State Foundation President.

Mr. Karim Maher was a successful real estate and municipal planning professional who understood how STEM professionals improve lives by designing and building well planned cities and residential communities. He valued higher education, supporting his children and extended family with their college educations. Mr. Maher also provided charitable support to organizations that helped under served youth achieve their dreams of advanced education.



"The A3L Federal Works generosity of establishing the Mr. Karim Maher Memorial Scholarship will directly impact Fairmont State students by giving them an opportunity to further develop their studies in the areas of science, technology, mathematics and engineering while continuing Mr. Maher's legacy," said Tori Anselene, Fairmont State Foundation Development Officer. "Fairmont State greatly appreciates those like A3L Federal Works, who provide opportunities for deserving students in STEM."

Mr. Maher believed that women should have a place in STEM fields, and Ms. Maher describes him as ahead of his time. He encouraged her to pursue her own engineering education and career.

"He was instrumental to my education as an engineer. I owe my drive to succeed and my can-do attitude to my father. His love and confidence in my abilities helped me aim high and achieve my goals," Maher said. "He was a great man, and he had a heart of gold. I hope to keep his memory alive and continue his legacy by starting this scholarship and supporting amazing West Virginia students."

As a business owner and a woman in a STEM field, Ms. Maher recognizes the demand for personnel with STEM education and she wants to encourage women and minority students to pursue degrees in such fields of study.

"Ms. Maher herself is a perfect example of the excellence one can achieve in STEM fields when a student is supported and encouraged," said Mirta M. Martin, Fairmont State University President. "And just as she was sustained by her father's support, we want to do the same for the next generation of STEM professionals, particularly creating opportunities for women and minorities who traditionally have not had proper exposure and access to STEM education. The Mr. Karim Maher Memorial Scholarship will allow us to further our efforts to provide that access, ignite the passion for STEM and help more students pursue their dreams."

When asked why she chose to support students at Fairmont State, Maher responded, "I am impressed with Fairmont State University and their curriculum in STEM. I have employees who are Fairmont State graduates, and they are highly qualified, outstanding engineers."

Diversified Gas & Oil Commits Additional Scholarship Funding to Fairmont State

Diversified Gas & Oil Co., the Birmingham, AL, company whose chief executive officer and co-founder is Fairmont State University graduate and Board of Governors member Rusty Hutson Jr., has committed an additional \$50,000 in scholarships over five years to Fairmont State students.

"Diversified Gas & Oil strongly believes in supporting students who attend colleges in our operating areas and that are seeking to start careers in the gas and oil or related industries," said Brad Gray, Executive Vice President and Chief Operating Officer. "We believe that the energy sector in the United States is strong and that it is a driver of economic prosperity for millions of people in the country. Our industry is a major factor in maintaining low energy costs for our country. At Diversified, we are very committed to our business operations in the Appalachian Basin."

Diversified donated \$30,000 in scholarships starting in 2019 for rising seniors earning a degree in a natural gas- and oil-focused major with an overall grade point average of 3.0 or higher. Each student selected receives a \$2,500 scholarship for their senior year. The additional contribution will extend the scholarship program for five more years through 2026.

Gray said that for the gas and oil industry to continue to be productive, innovative and successful, it needs a consistent talent pool of qualified, local, educated young people. Gray stated that the industry not only needs traditional engineers but also needs talented technology, finance, safety and environmental employees to manage the complexity of operations.

"We can think of no better place from which to source this talent -- young people from our back yards, our high schools, our universities," he said.

"For most of our students, paying for college is one of the most significant investments they and their families will ever undertake," said Mirta M. Martin, Fairmont State University President. "But they know that they are really investing in themselves. It's a sound investment, because Fairmont State graduates have a reputation for being highly skilled, hard-working and optimistic. And with their generous scholarships, Diversified Gas & Oil and Rusty Hutson are also investing in our students, easing our students' financial burdens."

Kestrel: A Journal of Literature and Art

Kestrel: A Journal of Literature and Art is the only print journal published by an institution of higher learning in West Virginia. Founded at Fairmont State in 1993 and publishing continuously since then, Kestrel publishes poetry, poetry-in-translation, fiction, creative nonfiction, art, and reviews. In 2009, Kestrel began its Celebration series, which brings contributors to each biennial issue to campus for two days of readings, panel discussions, class visits, workshops, and community outreach events like presentations to Marion County's Lifelong Learners and area high school classes. These Celebrations have currently brought nearly 200 writers from all over the country to Fairmont State (during the pandemic, Celebrations were held virtually, with contributors tuning in from as far away as Spain). In-person Celebrations have been supported by contributions from I-79 Honda.

The modest budget is supplemented by subscriptions, sales, and donations. Over the years the Journal has also received grants from the West Virginia Humanities Council, the National Endowment for the Arts, and from the Fairmont State Foundation. In 2016 the Friends of *Kestrel* program was launched to begin an endowment for the journal, and in the last two years, gifts received during the Foundation's Day of Giving were used to enrich that endowment.



Scholarship Created in Honor of Eric W. Underwood

Sidney and Judith Underwood of Parkersburg, West Virginia have pledged \$27,000 to create a scholarship in memory of their son Eric, who passed away in July of 2020. The Eric W. Underwood Endowed Scholarship will provide support to full-time students in the College of Science and Technology at Fairmont State University.

"The generous gift from the Underwood's is greatly appreciated. Their kind remembrance of their son will have a lasting benefit to Fairmont State students," said Fairmont State Foundation President Gary K. Bennett.

"We choose to honor Eric with this scholarship because he would want future generations to continue to pursue advanced education in this field of study," said the Underwoods. "As a young man, he collected model planes, ships and enjoyed watching trains. He loved drawing and it was natural that he studied drafting and engineering in college. Eric was fascinated with how machines, such as trains, worked. He studied them and could explain how the mechanics of their engines, brakes, worked. As an avid rail fan and member of the B&O Historical Association, he also enjoyed riding all the scenic rail works of WV. He loved music and learned to play guitar as an adult. He also enjoyed nature; hiking, riding bikes, and taking photos. During his time at Fairmont State, Eric held great respect for his instructors and the educational standards at the University."

Eric received an Engineering Technology degree from WVU Parkersburg before going on to complete a bachelor's degree from Fairmont State in Mechanical Engineering Technology in 2018. He also earned a master's degree in Technology Education from WVU. Eric was skilled in the areas of educational leadership and curriculum development.

"With the establishment of the Eric W. Underwood Endowed Scholarship, Eric's legacy will continue forever here at Fairmont State University," said Tori Anselene, development officer at the Fairmont State Foundation. "Students pursuing a degree within the College of Science and Technology will greatly be impacted because of Judith and Sidney's generosity."

The Eric W. Underwood Endowed Scholarship will be available to Fairmont State University students enrolled full-time at the College of Science and Technology. Applicants must be West Virginia residents with a minimum grade point average of 3.0.
